In Cambodia, FROM DESTITUTION **TO A VOCATION!**



The horrific genocide perpetrated by the Khmer Rouges left the country devastated, a complete breakdown of society, moral values along with systems of social solidarity were lost.



The main victims are the children scavenging on the municipal rubbish dump or street trading, often abused or exploited by traffickers, without food, without health care, without schooling.

Today, even though Cambodia is developing, many children and families are not benefitting.

Our Programmes

Since late 1995, PSE For a Child's Smile has operated in Cambodia to help children escape extreme destitution. Recognised by the Cambodian government, PSE has developed programmes tailored to the children's needs.

8,500 daily meals

2,400 consultations per week (doctors, nurses, psychologists, paediatric nurses)



Boarding or foster families are provided for children in danger or who live far away from the centre.
